Yiyi Chen, PhD [yiyi.chen@pku.edu.cn]

Dr. Yiyi Chen is Director of the Institute for Hebrew and Jewish Studies at Peking University. Chen has been one of the leading Biblical scholars in China, and recently, pioneers the field of Middle Eastern Peace Studies at Shanghai Jiaotong University. Chen is the Editor-in-Chief of the *Journal of Sino-Western Communications* in the US. He was a Visiting Professor in Graduate Theological Union (2008–2010) and the University of California at Berkeley (2006–2007). He also serves as a Peer-review College Member of England's Arts and Humanities Research Council. Chen is the author of several books, among them, the Chinese college standard textbook *Introduction to the Hebrew Bible* (Peking University Press, 2011) and *Textual and Archaeological Background of the Hebrew Bible* (Kunlun Press, 2006). His Chinese translation of A. B. Yehoshua's Hebrew novel *Three Days and a Child* was awarded the annual prize by Israel's Institute for the Translation of Hebrew Literature in 1994. Chen heads several Chinese government commissioned projects related to Jewish Studies, the Bible, Israel and the Middle East. He leads the only Chinese think tank initiative to publish a Middle East Peace Index at Shanghai Jiaotong University.

Robert Crane, PhD [qfisinfo@qfis.edu.qa]

Dr. Robert Crane (also known as Faruq 'Abd al Haqq) is Professor at Qatar Faculty of Islamic Studies and a life-long expert in long-range global forecasting for government and industry, with professional work ranging from his Directorship for Third World Studies at the Hudson Institute to his current position in 2012 at the Qatar Foundation in Doha as Director of the Center for the Study of Contemporary Muslim Societies. In 1962, he became one of the four co-founders of the first foreign affairs think-tank in Washington, the Center for Strategic and International Studies. He was the principal foreign policy adviser from 1962 to 1967 for Richard Nixon. In 1981, President Ronald Reagan appointed him U.S. Ambassador to the United Arab Emirates. He is a founding president of the Harvard International Law Society and editor-in-chief of its journal, and headed a project for the U.S. Supreme Court on the constitutionality of international law. Since 1982, Dr. Crane has worked as head of his own think-tanks on developing global ethics as a framework for peace, prosperity, and freedom through the interfaith harmony of normative and compassionate justice. In this capacity he has published several hundred professional articles and four books primarily on normative Islamic jurisprudence, including the first textbook ever written on Islam and Muslims, an 800-page, two-volume work that he and Mohammad Ali Chaudry completed in 2011 as the Chairman and President, respectively, of the Center for Understanding Islam.

Lawrence Davidson, PhD [ldavidson1945@msn.com]

Dr. Lawrence Davidson is Professor of History, West Chester University in Pennsylvania. His academic work is focused on the history of American foreign relations with the Middle East. Many of Dr. Davidson's recent articles have appeared in *Logos*, an on-line journal for which he is a contributing editor. In March 2012 his book, *Cultural Genocide*, was published by Rutgers University Press. His other books include: *Islamic Fundamentalism-An Introduction* (Greenwood Press). An updated third edition of this work published by ABC-Clio, will appear in 2013; *Privatizing America's National Interest* (University Press of Kentucky, 2009); *America's Palestine: Popular and Official Perceptions from Balfour to Israeli Statehood* (University Press of Florida, 2001); and with Arthur Goldschmidt, published the eighth edition of *A Concise History of the Middle East* (Westview Press, 2006 and 2012). The Concise History is probably the most widely used textbook on Middle East history in the United States.

At Georgetown University Dr. Davidson studied modern European intellectual history under the Palestinian expatriot Professor Hisham Sharabi. Many of his articles appear in the early issues of the *Journal of Palestine Studies* edited by Professor Sharabi.

Jerome Drevon, PhD candidate [jerome.drevon@durham.ac.uk or jerome.drevon@gmail.com]

Jerome Drevon is a doctoral candidate at Durham University in the United Kingdom where he specializes in the study of Islamist armed groups in the Middle East. He is a Junior Research Fellow of the Swiss National Science Foundation (SNSF) and his research interests lie in Security Studies and Social Movement Studies. He is currently focusing on the evolution of Islamist armed groups in ideologies and practices. His PhD is centered in particular on the evolution of two Egyptian militant groups, the al-Jama'ah al-Islamiyah (Islamic Group) and Jama'ah/Tandhim al-Jihad (The Jihad Group/Organization). He interviewed most of their leaders and senior members during his stay in Egypt, as well as dozens of militants and sympathizers. He has recently presented preliminary results of his research in conferences in several British universities and in Australia and intends to publish them shortly. Before joining the academia, Jerome has extensively travelled the region and lived in Egypt, Lebanon, the occupied Palestinian territories and Syria. In this context, he worked in several NGOs and research centers in Europe and in the Middle East, where he acquainted himself with the academic study of armed violence as well as with Human Rights law.

Dr. Taef el-Azhari is Associate Professor of International Affairs at Qatar University. His specialization is the Saljuqs history of Syria and his research and teaching interests include: Middle East Studies, Crusades, International Affairs, Ayyubid history, Women in Islam, Zengids, and Saljuqid/Turkmen history. His most recent and forthcoming works include: "The Career of Balak the Artukid, in *Orientalia Lovaniensia Anylecta*. vol. VII" (Belgium), "The Power of Eunuchs in the Fatimid dynasty 909–1171" (Hawwa, Brill), and the book, *Zangi and the Muslim response to the Crusades, 1084–1146* (Edinburgh University Press). He has taught courses on: History of Medieval Egypt 640–1171 A.D.; Islamic Civilization in English and Arabic Language; Abbasid history; Saljuq; Fatimid history and the Crusades; and Middle Eastern history. Dr. el-Azhari is a member of the Society of the Study of the Crusades and the Latin East, England–U.S.A.; the Society for the Medieval Mediterranean, Leeds University–England; the American Historical Association; and the Japan Association for Middle Eastern Studies; and is a research fellow at Leiden University. He has lectured and presented at many international conferences and has been sought for academic consulting on many multimedia ventures: He has been an advisor to the documentary series *Crusades: The Crescent and The Cross* with Lion Television for the History Channel, for a report titled *Crusades and Modern Middle East* for CBS News/60 Minutes, *Islam and the Mediterranean* and *The Crusades*—both for the BBC, and a documentary about Al Jazeera in 2011. He is the author of the 1997 book "The Saljuqs of Syria During the Crusades 463–549" (Klaus Schwarz, Berlin), and is the recipient of several grants and scholarships including a Fulbright Commission in Egypt and CIES.

Hend Eltaweel, MA, is Administrative Assistant, Office of the Dean, American University in Cairo. Ms. Eltaweel has been working under the supervision of GAPP Founding Dean, Ambassador Nabil Fahmy since 2010. Eltaweel attained her Bachelor of Arts in Business Administration with Minor in Political Science at AUC in 2008 where she is currently pursuing MA in Middle East Studies. Eltaweel is interested in Middle East politics with special focus on political Islam, Islamic revolution in Iran and the role of religion in mobilizing societies. Despite her young age she has carried several travels across Europe, Asia, the Middle East and the U.S. She plays an active role as student liaison at the Committee for Middle East Studies at AUC. Amitai Etzioni, PhD [etzioni@gwu.edu]

Dr. Amitai Etzioni is University Professor and Professor of International Affairs and Director of the Institute for Communitarian Policy Studies at George Washington University. In 2001, he was named among the top 100 American intellectuals as measured by academic citations in Richard Posner's book, *Public Intellectuals: A Study of Decline*. After receiving his Ph.D. in Sociology from the University of California, Berkeley in 1958, Etzioni served as a Professor of Sociology at Columbia University for 20 years; part of that time as the chairman of the department. He was a guest scholar at the Brookings Institution in 1978 before serving as a senior advisor to the White House from 1979–1980. He has served as the Thomas Henry Carroll Ford Foundation Professor at the Harvard Business School, as the president of the American Sociological Association, and was the founding president of the International Society for the Advancement of Socio-Economics. In 1990, he founded the Communitarian Network, a not-for-profit, non-partisan organization dedicated to shoring up the moral, social and political foundations of society. He was the editor of *The Responsive Community: Rights and Responsibilities* from 1991–2004 and has authored 24 books. In 1991, the press began referring to Dr. Etzioni as the "guru" of the communitarian movement and can be seen and heard frequently in the media. In 2001 he was awarded the John P. McGovern Award in

Behavioral Sciences, as well as the Officer's Cross of the Order of Merit of the Federal Republic of Germany. He was the recipient of the Seventh James Wilbur Award for Extraordinary Contributions to the Appreciation and Advancement of Human Values by the Conference on Value Inquiry, and the Sociological Practice Association's Outstanding Contribution Award.

Amir Abbas Fakhravar [info@fakhravar.com]

Amir A. Fakhravar is Research Fellow and Visiting Lecturer at the Washington-based *Institute of World Politics*, President of the Iranian Freedom Institute and founder of Confederation of Iranian Students. He is the recipient of Annie Taylor award, contributor to the Iranian newspapers Khordad and Mosharekat and author of “Still, the Scraps of Prisons” (2005), “This Place is not a Ditch!” (2000), and “The Greenest Eyes on Earth” (1998). As a political prisoner, his treatments in the Iran’s notorious Evin prison was described by Amnesty International as first known example of “white torture” in Iran. In 2006 he settled in the US and met with President Bush, members of congress, scholars, and policy makers to discuss the atrocities of the Islamic Republic. Fakhravar has testified before the Homeland Security and Governmental Affairs Committee of the US Senate (July 2006) and the House Foreign Affairs Committee (April 2011) addressing US-IRAN relations and Iran Nuclear Program. Amir Fakhravar has briefed members of several parliaments all around the world including UK, Canada, EU, Finland, Germany, Italy and Israel on Iran issues specially sanctions on Iran's Oil and Central Bank. In February 2012 he was invited to address the 12th Annual Herzliya Conference and the Knesset. He spoke at a panel with Vaclav Havel, Natan Sharansky and Jose Maria Aznar at the International Democracy and Security conference in Prague in June 2007.

Dr. Chris Ferrero is Visiting Faculty at the Whitehead School of Diplomacy and International Relations at Seton Hall University in South Orange, New Jersey. Dr. Ferrero specializes in Iran, US-Iran relations, the role of Islam in foreign policy, and the Israeli-Palestinian conflict. He earned a Master of Arts degree with Honors in National Security Studies from the Georgetown University Edmund A. Walsh School of Foreign Service in 2003 and his PhD in 2011 from the University of Virginia. González became a research fellow at the Institute for the Studies of Religion at Baylor University in central Texas. She received her PhD and MA degrees in Sociology from Baylor University and received a BA in Sociology and Policy Studies from Rice University. She is the principal investigator of the Islamic Social Attitudes Survey Project, a study in conjunction with Baylor’s Institute for the Studies of Religion on Islamic Religiosity and Social Attitudes, including Women’s Rights Attitudes in the Arab Gulf Region. Susmit Kumar, PhD [susmitk1@gmail.com]

Dr. Susmit Kumar is President of Kumar Consultancy, US. He received his doctorate in 1992 from Pennsylvania State University. Before coming to the United States, he was selected in the prestigious Indian Administrative Service and did its training at the Lal Bahadur Shastri National Academy of Administration, Mussoorie, India. He is the author of "The Modernization of Islam and the Creation of a Multipolar World Order" (Booksurge, January 2008), "Casino Capitalism: The Collapse Of The US Economy And The Transition To Secular Democracy In The Middle East" (iUniverse, 2012), and "Karma, Mind, and Quest for Happiness: The Concrete and Accurate Science of Infinite Truth" (iUniverse, 2012). The first book was an extension of his 1995 article published in *Global Times*, Denmark. In this article, based on the analysis of the social, political and religion environments in the Middle East, Dr. Kumar predicted the global rise of Islamic militancy due to the 1980s US intervention in Afghanistan, takeover of Middle East and North African Islamic countries (including Saudi Arabia) by fundamentalist Muslims which may result in a temporary revival of Caliphate system and also its final outcome. In a 1996 article he wrote, "Afghanistan was a Waterloo for the U.S.S.R. but it might become a Frankenstein for the U.S."

Dr. Maria Frederika Malmström is Researcher for North Africa in the Conflict, Security and Democratic Transformation Cluster at the Nordic Africa Institute. Since 2010 she is a visiting scholar, 2010–2012, at the Center for the Study of Gender and Sexuality at New York University and from 2012 Performance Studies, Tisch School of the Arts. Additionally, she is a gender consultant (UNFPA, UNICEF and others), and member of several academic/policy networks, e.g. Think Tank for Arab Women and the Nordic Network – FOKO – Research about female circumcision. She has a PhD in Social Anthropology, School of Global Studies, University of Gothenburg, Sweden 2009 and a MA, Social Anthropology, Department of Social Anthropology, University of Gothenburg, Sweden 2000. Malmström received her PhD from the School of Global Studies, Social Anthropology, University of Gothenburg, Sweden. Her dissertation examined how female gender identity is continually created and re-created in Egypt through a number of daily practices, of which female circumcision is central. The study explored how the subject is made through the interplay of global hegemonic structures of power and the most intimate sphere, which has been exposed in the international arena.

He taught for several years at the Philosophy Department of the University of Pennsylvania. Subsequently he shifted from the academic world to government, starting as an aide to Congressman Donald M. Later he worked for the US Agency for International Development, first as Coordinator for the Near East and then as Senior Advisor for Agency Planning. In 1987, Dr. Segal was a member of the first American-Jewish delegation to meet with the PLO leadership in Tunis. In 1988 his writings in *Al-Quds* and other publications played a catalytic role in promoting the Palestinian Declaration of Independence—issued in Algiers in November 1988. He also played a role in back-channel contacts that led to the opening of the US-PLO dialogue in December 1988. Dr. Segal is the author of six books and over 100 articles and op-ed pieces on the Israeli-Palestinian conflict published in *The New York Times*, *Washington Post*, *Los Angeles Times*, and *al-Quds*.

Dr. Ivan Sascha Sheehan is Assistant Professor of Public and International Affairs at the University of Baltimore where he is Director of the Negotiation and Conflict Management graduate program and founding Co-Director of the Global Affairs and Human Security graduate program. Dr. Sarah Tobin is a Mellon Post Doctoral Fellow in Islamic Studies, Department of Anthropology at Wheaton College, Norton, MA. Her expertise is in Islam, economic anthropology, and gender in the Middle East. Ethnographically, her work focuses on Islamic piety in the economy, especially Islamic Banking and Finance and during times of economic shifts. She is the author of *Everyday Piety: Islam and the Economy in Amman, Jordan*, which is currently under review at Cornell University Press. It draws on 21 months of participant observation in Amman, Jordan, including the first ethnographic study conducted inside an Islamic bank. She is the editor of a volume in progress entitled, *Faith and Finance: Anthropological and Sociological Perspectives on Islamic Banking and Finance*.
